



# Application for Building Permit

All property must be properly platted; zoned and all required public improvements either installed or addressed with three-way contracts before a building permit may be issued. To ensure adequate review, the proper number of plans, site plans, and complete building application submittal is required. Note that an engineer, when required by the Texas Engineering Practice Act, must seal plans.

Applicant is responsible for all work done under this permit, and must follow all applicable codes.</p>
